

# My Care Circle

Empowering Patients Through Stronger Care Management



My Care Circle is an open source, FHIR-based care coordination platform that streamlines care management across community providers. By offering a standards-based set of questionnaires that define care pathways (medical, behavioral health, and social services), the system generates a comprehensive care plan that can be accessed and shared by all care team members.

My Care Circle uses care plan templates with care goals for the person and/or their guardians and enables screening assessments, tasks and reporting within the system or from third-party sources. The affordable solution does not require ongoing licensing fees to facilitate coordination between practitioners from multiple organizations.

## Care Coordination Redefined

Person and their families can use the online assessment to determine their health complexity score, and based on the results, receive community-based care coordination from a team of community health workers, social workers, and others.

Based on an Administration for Children and Families opensource platform, the Operational Data Hub (ODH), My Care Circle platform enables community providers to improve care coordination and achieve person goals.



Ingests person-centric clinical and non-clinical data



Provides secure data access to organizations and team members by relevant care management role



Improves the ability to manage person care



Connects to external data sources (such as claims data)



Offers a holistic view of a person's needs



Facilitates the exchange of data to and from My Care Circle.



My Care Circle is currently utilized by the New Jersey Integrated Care for Kids program (NJ InCK), a transformative initiative to improve care for children through prevention, early identification, and treatment of complex behavioral and physical health challenges. NJ InCK is supported by the Centers for Medicare and Medicaid Services (CMS) of the U.S. Department of Health and Human Services (HHS) as part of an award totaling \$1,998,437.



My Care Circle is also used by the CT-Integrated Care for Kids (CT InCK) – Embrace New Haven program. Clifford Beers, a CT InCK program participant, has been selected by CMS as one of the nation's recipients for the (InCK) Model award. Clifford Beers' award is designed to address the physical, mental, and social health of enrollees in Medicaid and the Children's Health Insurance Program (together known as HUSKY Health in Connecticut). The seven-year initiative is part of CMS' strategy to fight the opioid crisis and address its impact on children, youth, their caregivers, and expectant mothers.
